2. Rules and Regulations: Exhibitors must abide by all rules and regulations of the event venue. Only one company may exhibit per booth, unless otherwise approved by Producers. Producers reserves the right to request the removal of any items displayed within Exhibitor's booth that, in its sole judgment do not conform to event guidelines. Violation of this agreement is grounds for removal of an Exhibitor from the event, at Exhibitor's expense and with no refund. Exhibitors must confine their activities to their contracted space; leafleting outside Exhibitor's booth is prohibited. Exhibitors may not accept any payment for product or services from attendees. Exhibitors are prohibited from using amplifying equipment during event hours; helium balloons are prohibited. Producers reserves the right to modify Rules and Regulations at any time.
3. Exhibitor Load-In, Dismantling and Load-Out: Exhibitor will arrange for the shipment of any materials, displays, furniture, etc., for use in its exhibit space, per directions found in Exhibitor Confirmation Package. Materials, displays, etc., may not be brought into Exhibit Hall during Exhibit Hours without consent of Global Learning Partners (GLP). Exhibitors must wait until the event has ended before dismantling, packing or removing materials.
4. Space Assignments: Exhibitors will be given an opportunity to select their booth location based on date of paid-in-full contracts. GLP reserves the right to change space assignments prior to the event. Space is leased with the understanding that the Exhibitor will hold Global Learning Partners harmless from any and all liabilities that may result from any changes.
